Thank you for your letter of April 3. I am very sorry to hear of your family's medical crisis. I hope your daughter's surgery went well and that she is enjoying aspeedy recovery. In our practice, we see so many families with special needs children, we are certainly quite aware and appreciative of how important the entire family is to their well-being.

Thank you also for your consideration of our final invoice with respect to your corporation's 501(c)(3) certification. In response to your request, I enclose a copy of our invoice number 69034, dated December 20, 2010. This invoice reflects your company's payment of our initial flat fee for preparation and filing of the Form 1023 (\$2,500), plus the costs associated with that work. The costs total \$943.54, \$850 of which was the IRS filing fee which accompanied the Form 1023 when we filed it on your behalf.

In light of your personal circumstances and your company's continued attention this matter, we will extend our offer to accept \$2,000, plus costs of \$73.77, although the time charges for the post-filing work were in excess of \$3,300.
